

FLEX Application "Mail In"

Welcome to JUMP's new mail in FLEX application to receive assistance. Every three months participants in need can mail in their completed FLEX application with a copy of Proof of residency; OPEN current heating or electricity UTILITY BILL showing date, name, address and account to determine residency **or** Valid Vermont State ID with matching address and reachable phone number to be contacted. If requesting Shell Gas Card; must provide proof, a photocopy of the "valid car registration with matching address and a photo the VT State ID of all names on the car registration". If requesting Utility assistance; must submit bill with matching residency address.



Once reached by phone and confirmed, the participant will receive by mail in 2-4 days a \$30 Hannaford, \$30 City Market, \$25 Shell gas card to purchase groceries, transportation gas assistance, cleaning supplies, prescription co-pay and basic essential goods or \$50 Utility Bill assistance. *Currently, JUMP is only able to help clients with proof of residency.*
